EATNOVATE: THE CIRCULAR TRUTH DEALING WITH FOOD LOSS AND FOOD WASTE



It is estimated that 342,000 tonnes of food is lost from farm to market within Singapore. This contributes to billions of dollars of food lost occurring in Singapore at the production, post-harvest handling and storage, processing and packaging, and distribution stages according to a study by Singapore Environment Council (SEC) together with knowledge partner, Deloitte & Touche Enterprise Risk Services Pte Ltd.

The study seeks to understand not only the scale of food loss but drivers causing this dilemma. It will help contribute to a much broader and better understanding on how food loss in the supply chain can be managed and reduced to help achieve Singapore's goal of "30 by 30" to produce 30% of Singapore's nutritional needs locally by 2030.

SEC Conference Day serves as a platform to spark conversations and discussions for business and government leaders to ascertain, develop and share innovative solutions to address food loss challenges from farm to market. We look forward to a lively discussion at the two panel sessions to help shape the food ecosystem in Singapore.

Time is running out.

In 2018, the Intergovernmental Panel on Climate Change (IPCC) issued one of the starkest warnings from the scientific community: an increase of 1.5 degrees Celsius in global warming could occur as early as 2030. The warning is loud and the message is clear: we must act now.

Being environmentally sustainable has always been our choice. In Singapore, we took early actions to protect our environment and improve our resilience against environmental threats. We greened our city, used natural gas to generate most of our electricity, and ensured a resilient water supply. Climate change has made it critical that we stay on this path of sustainable development. As part of Singapore's Climate Action Plan, we are investing in solar, developing more sustainable buildings, expanding public transport, and we have frozen the growth of the car population. We have implemented a carbon tax from 2019, to enhance energy and carbon efficiency, and help transition our economy to a

low-carbon future. We have achieved the circular economy in our water sector, by endlessly recycling the water we use. Going forward, we will also pursue the circular economy in the waste and material resources sector, particularly focusing on e-waste, plastics and food waste.

We will also intensify our climate adaptation efforts. In the next two years, we will spend another \$400 million to upgrade and maintain our drains. We will further diversify our food imports and develop our agri-food industry to produce 30 per cent of Singapore's nutritional needs by 2030. We are also launching a \$10 million National Sea Level Research Programme over the next five years. This will strengthen our understanding of sea levels around Singapore and help us to develop more robust sea level rise projections.

Climate change cannot be tackled by Government alone. We need all sectors to join us on our journey to move Singapore towards a zero waste vision and a climate-resilient future. The Singapore Environment Council's joint position paper with Deloitte on food loss and food waste is timely. The insights from its study will complement efforts to strengthen Singapore's food resilience. I am also encouraged by the increasing number of companies which are adopting sustainable practices.

The 22nd Singapore Environmental Achievement Awards (SEAA) plays an important role in acknowledging the efforts of companies which have demonstrated commitment to environmental excellence and protection of our natural environment in their business operations. I commend the efforts of all the applicants, and extend my congratulations to the SEAA winners. Thank you for working with us to build a Sustainable Singapore for our future generations.

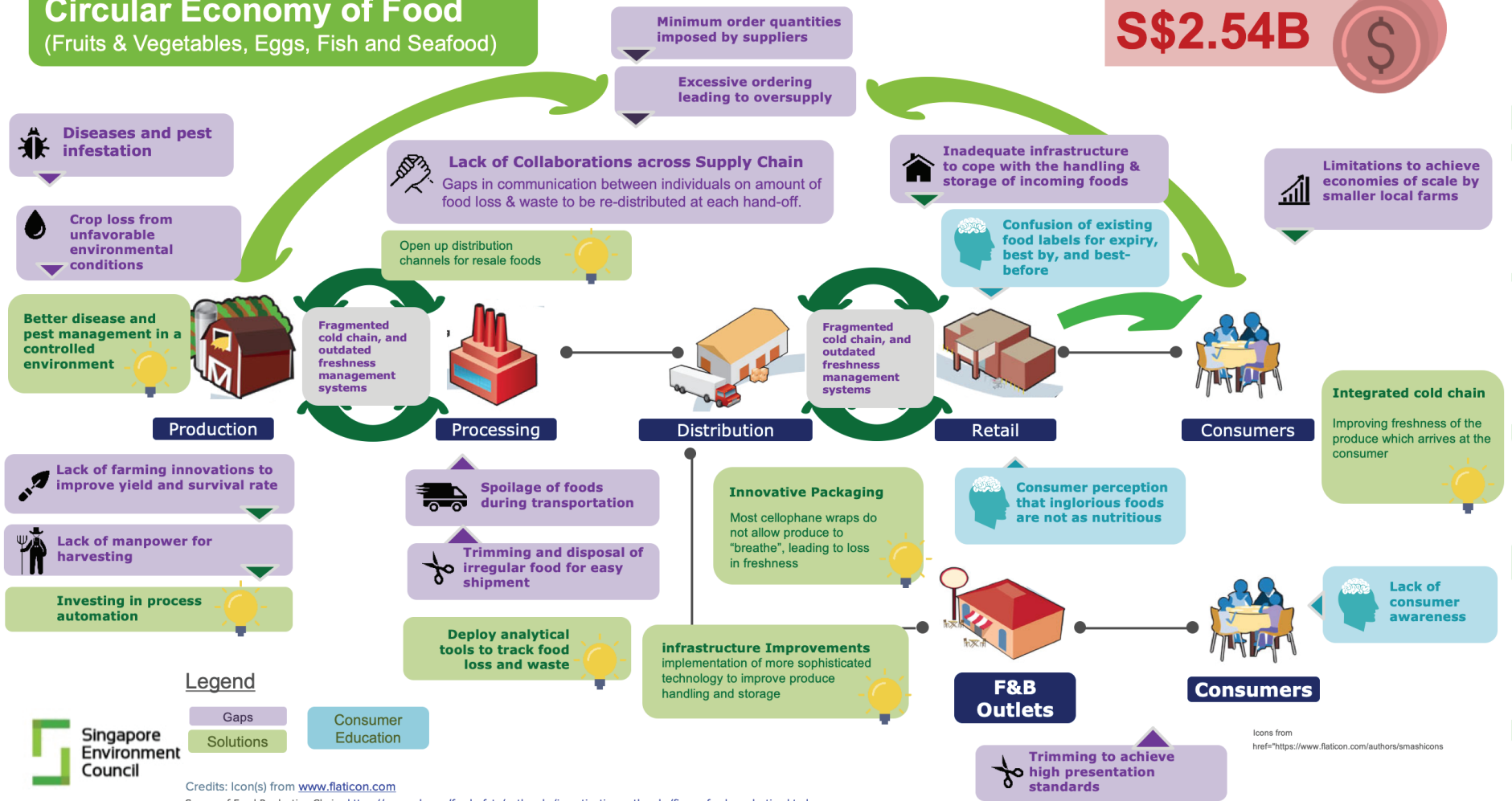

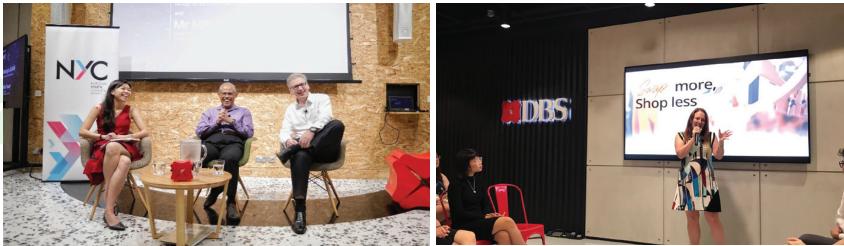

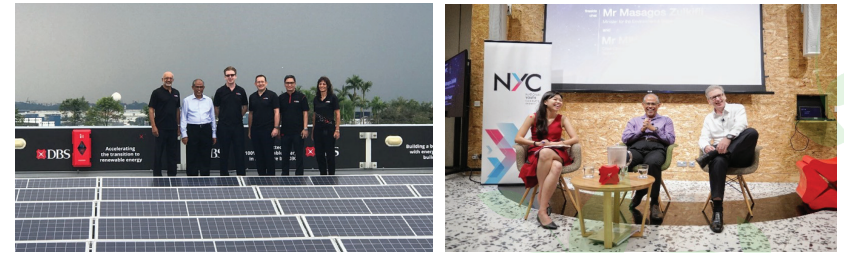
